## **Affidavit For Undocumented Immigrant Student Tuition Rate**

As an open-admission institution, <u>Wor-Wic Community College</u> grants admission to all students regardless of citizenship. Maryland Senate Bill 167 provides the opportunity for some non-U.S. citizens in Maryland to be exempt from paying the out-of-state tuition rate.

- 1. I attended a public or nonpublic high school in Maryland for at least 3 academic years not earlier than the 2005-2006 school year;
- 2. I graduated from a public or nonpublic high school in Maryland or received the equivalent of a high school diploma from the State not earlier than the 2007-2008 school year;
- 3. I, or my parent or legal guardian, have filed Maryland income tax returns:
  - i. annually, while I attended a high school in Maryland; and

- ii. annually during the period, if any, between graduation from high school and enrolling in a community college; and
- iii. I will continue to submit proof of tax filings each year I am enrolled at the community college;
- 4. I am enrolling at this institution not later than 4 years after graduating from high school or receiving a GED;
- 5. I will file an application to become a permanent resident within 30 days after becoming eligible to do so.
- 6. I have registered with the Selective Service System. (This applies to all males 18 and older. You must submit a copy of proof of selective service registration. This can be obtained from your local post office).
