Award Recommendation: Facility Program Part I and Part II Consulting Services. The RFP evaluation committee scored those proposals and short-listed three contractors who were invited for oral presentations on July 9- 10, 2024. The evaluation committee then scored the oral presentations and I opened price proposals from the top two scoring firms. Scores were weighted 70% technical and 30% price.
