2024-25 COMMUNITY COLLEGE TUITION WAIVER CERTIFICATION FORM FOR STUDENTS WITH DISABILITIES RECEIVING SSDI OR SSI

In order to be eligible to receive a tuition waiver for students with disabilities receiving SSI or SSDI, students must complete this certification form, provide the required supporting documents, and meet the following criteria:

Eligibility Criteria

- Complete the Free Application for Financial Aid (FAFSA) by the March 1st deadline for each academic year; (deadline extended to May 15 in 2024-25)
- Complete a waiver certification form for Wor-Wic Community College each academic year; and
- Maintain Maryland residency.

Awarding Information

- The tuition waiver is only applied toward the cost of tuition. Fees and textbooks costs will not be waived.
- All eligible grant and scholarship funding will be applied towards the cost of tuition first.
 - o If the student is not eligible for other sources of aid then the tuition waiver will be applied for the full amount of tuition.
 - o If the student is eligible for other sources of aid but the aid does not cover the full cost of tuition then the tuition waiver will be applied toward the remaining balance only.
- Individuals receiving SSDI or SSI benefits as a dependent survivor of a disabled beneficiary do not qualify for this waiver.
