## PLEASE UPLOAD/SUBMIT ALL THE FOLLOWING DOCUMENTS TO BE CONSIDERED:

### Required **STUDENT** documents:

- Birth Certificate
- Immunization Records & Current Physical Form
- IEP or IFSP, if applicable

### Required **PARENT/GUARDIAN** documents:

- Parent(s) or Legal Guardian(s) Driver's License or State-Issued Picture ID
- State of Maryland Benefit Eligibility Letter, if applicable
- Proof of Income for PreK 3 and PreK 4 ONLY
  - 4 most current & consecutive pay stubs
  - W-2's OR 2022 tax return
- 2 Proof of Residency documents in a parent's or legal guardian's name (examples below)

### Proof of Residency Documentation

Homeowner: Mortgage / Property Tax Bill AND at least one of the following:	Renter / Lessee: Current Rental / Lease Agreement AND at least one of the following:
Current gas bill that states service address Current water bill that states service address Current electric bill that states service address	

### **Public School Only** -Residency Statement –

If you are the parent or guardian of a student and you do not have the proof of residency documents listed above, you and the homeowner/renter/lessee must schedule an appointment with Student Family Services at 410-677-4501 to complete a residency statement. In addition to the documents listed above, the parent or guardian will need one of the following:

- Current utility bill (water, electric or gas) ·
- Current official government correspondence (ex. social services, court subpoenas, state health insurance)

**All parties must present picture ID to complete the residency statement.**
