\_\_\_\_\_ I understand that this educational benefit does not pay tuition and fees to the college. If I am not approved for financial aid (Pell Grant, scholarships, loans) I am responsible for making tuition and fees payments to Wor-Wic **before the semester begins** to ensure that I am not dropped from my class/es.

\_\_\_\_\_ I understand that if I qualify for a monthly stipend, the VA will pay me my monthly stipend in *arrears* – meaning my monthly VA payment is normally received the first week of each month after the last day of the prior month of training. The VA pays the monthly stipend based on my enrollment status each semester (full time, 3/4 time, 1/2 time, etc). My monthly stipend is paid to me via my direct deposit bank account or a check depending on my option.

\_\_\_\_\_ I understand that I must notify the Wor-Wic Director of Veterans Services after I register for classes and that I must notify the Director of Veterans Services whenever I add, drop or withdraw from classes. I also understand that I must notify the Director of Veterans Services if my degree plan changes. (Notifications should be made within 24 hours of changing my schedule or degree plan. Failure to notify the Director of Veterans Services of schedule changes/degree changes may result in delayed payments and/or my indebtedness to the college and VA).

\_\_\_\_\_ I understand that the VA will pay benefits only for the courses required for my current degree plan. Each semester the Wor-Wic Director of Veterans Services verifies my scheduled classes to confirm that each class is required for my degree plan. Courses not required for my degree plan will not be certified to the VA.

\_\_\_\_\_ I understand that if I receive an "F" grade as my final course grade it will result in an inquiry by the Director of Veterans Services to my instructor/s to determine the reason/s leading to my "F" grade. I understand that "F" grades may be reported to the VA and may result in my indebtedness to the VA. I understand that failure to maintain satisfactory attendance and satisfactory academic progress (SAP) may result in my indebtedness to the VA. Should I ever be placed on academic probation or suspension, the Wor-Wic Director of Veterans Services will notify the VA of my academic status.
